4. Some law firms specialize in litigation practice, others specialize in Transactional practice, such as real estate, contracts, and corporate law. Some do both types of law.
5. A firm specializing in a limited area of practice, such as entertainment law, may be called a Boutique firm.
6. Each state's Highest Court is ultimately responsible for regulation of the practice of law in that state.
7. A lawyer who has had his/her license permanently terminated is said to be Disbarred.
