- A set of activities designed to ensure that the development and/or maintenance **process** is adequate to ensure a system will meet its objectives.

- QA activities ensure that the process is defined and appropriate.

Methodology and standards development are examples of QA activities.

- A QA review would focus on the process elements of a project - e.g., are requirements being defined at the proper level of detail.

- QA is set of activities whose purpose is to demonstrate that an entity meets all quality requirements.

- This is done by adopting a standard set of process and usual QA techniques like review, training, facilitation etc.

- It can be termed as defect prevention.

- Quality assurance is an audit function.
