was paramount the Apostolic Succession essential a Cyprianist mentality colored everything they held a conscientious regard for oaths the Usages Controversy brought Tradition to the fore printing presses replaced lost pulpits patronage was a means of protection and proliferation they lived with a hybridized conception of time creative women spiritual writers complemented male bishops and a global ecumenical approach to the Orthodox East was visionary These ten operated synergistically to create an effective tool for the Nonjurors survival and success in their mission The Nonjurors influence out of all proportion to their size was due in large measure to this mentality Their unique circumstances prompted creative thinking and they were superb in that endeavor These perspectives constituted the infrastructure of the Nonjurors world and they help us to see the early eighteenth century not only as a time of rapid change but also as an era of persistent older religious mentalities adapted to new circumstances
