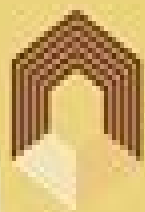

Neoclassical corporate finance theory unambiguously choose marginalist price theory rather than welfare economics as the source of its working assumptions thus guaranteeing the irrelevance of not only the individual shareholder but also of managers Or to say it differently the neoclassical concept of the corporation did not merely separate ownership from control it separated corporate decision making from all human preference whatsoever unless those preferences were simply asserted to be maximization of value Within the neoclassical model the separate human identities of shareholders or even managers came to matter only under the rubric of agency costs which were regarded as nothing more than an imperfection in the neoclassical corporate ideal
