Nuclear energy is the third most common energy source after fossil facts and renewable energy worldwide. Nuclear energy provides about 10% of the world's electricity currently. However, there has been a growing discussion over nuclear energy because of its risks and benefits. Supporters argue that nuclear energy does not release direct greenhouse gas emissions which is considered a solution to global warming. Opposents claim that nuclear energy pose risks to the environment and public health due to the potential nuclear accident events. There are hard and soft nuclear energy laws that regulate nuclear safety at the international level. However, the latest nuclear accident, The Fukushima nuclear accident, shows that international nuclear law could be not an effective tool to achieve nuclear safety all over the world. For this reason, the role of international nuclear law on nuclear safety stays questionable. The main purpose of this paper is to argue the weaknesses and strengths of international nuclear energy regulations to achieve nuclear safety and regulate nuclear accident-related risks to the environment and public health.
