Thus the author refutes claims that the native French Jewish elite was overwhelmingly unsympathetic to the refugees because of fear that an influx of refugees would provoke an antisemitic backlash While this book reveals the extent to which anti refugee attitudes and policies in the 1930 s paved the way for Vichy's anti Jewish policies it also highlights significant discontinuities between the refugee policies of the Third Republic and those of the Vichy regime **Municipal Reference Library Notes** ,1936 Going it Alone David B.
