

POLITICAL LAW (Consti 1-2, Admin, Law of P.O and Law on Municipal Corpo)

- A Branch of public law which deals with the organization and operations of the governmental organs of the State and defines the relations of the State with the inhabitants of its territory. (Macariola vs. Asuncion)

Likewise, in *People vs. Perfecto* (43 Phil. 887, 897 [1922]), this Court stated that: "It is a general principle of the public law that on acquisition of territory the previous political relations of the ceded region are totally abrogated.

CONSTITUTIONAL LAW - is the study of the maintenance of the proper balance between authority as represented by the three inherent powers of the State and liberty as guaranteed by the Bill of Rights

A CONSTITUTION- according to Cooley, is "that body of rules and maxims in accordance with which the powers of sovereignty are habitually exercised."

A constitution is a written instrument by which the fundamental powers of Government are established, limited and defined, and by which the powers are distributed among several department for their safe and useful exercise for the benefits of the people. (*Manila Prince Hotel vs. GSIS, February 3, 1997*)

by Justice Malcolm, - the written instrument enacted by direct action of the people by which the fundamental powers of the government are established, limited and defined, and by which those powers are distributed among the several departments for their safe and useful exercise for the benefit of the body politic."

Purpose of the Constitution

The purpose of the Constitution is to prescribe the permanent framework of a system of government, to assign to the several departments their respective powers and duties, and to establish certain first fixed principles on which government is founded.

It is through the constitution that the fundamental powers of government are established, limited and defined, and by which these powers are distributed among the several departments. (*Biraogo v. The Philippine Truth Commission December 7, 2010*)

A doubtful provision shall be examined in the light of the history of the times and the conditions and circumstances under which the Constitution was framed (Civil Liberties Union v. Executive secretary, February 22, 1991)
